Legislative Report-**Betty Weller**

The 2025 Legislative session is over. A total of 2614 bills were submitted and the Maryland Retired School Personnel Association followed 31 of them which were related to our legislative agenda.

We opposed 12, 4 dealt with the budget and the others were curriculum related. Depressed spending, nominal population growth, the loss of pandemic money, cuts hat needed to be restored and the Blueprint were among the reason for the \$3 billion shortfall.

Some money has been shifted back to the counties, a change in the tax structure, a 3% tax on IT services and a slight increase in the piggy back tax (from 3.2 to 3.3) were some of the steps taken to ultimately pass a balanced budget.

The Governor had until May 27, 2025 to either sign or veto the bills. Anything not signed or vetoes will become law.

KCRSPA executive meeting: 5/1/25

- We met at Sumner Hall on 5/1/25. Members in attendance were: Glenn, Nancy (her last meeting as president!), Debbie Smith, Charlotte, Betty, Sue Crooks, Nina, Sue Clark, Kathy, and Brenda. We pledged allegiance and approved the minutes from our Feb. 6th executive meeting.
- -Debbie gave her finance report, which we accepted and voted for approval.
- -We must have our books audited before Sue Clark and Nina take over as co-presidents.
- -We also need to create a budget before the June meeting on the packet. Those who will work on the budget are Nancy, Debbie, Kathy, Sue Clark, and Nina. Another budget item to be added to our list of budget items is printing funds.
- -For the Turf Valley meeting, (4) members will attend as delegates with Nancy as the chauffeur.
- -Betty shared our membership needs to be raised. The word audit will no longer be used but the word review will replace it. Legislative news: 2,600 bills were brought up in the legislative session but only (4) bills were supported. Some of the failed bills had to do with curriculum for the state. The loss of pandemic money is being felt in the state. The state is also trying to grow new teachers.
- -We will treat our county teachers again with "goodies"/"treats" in the fall.
- -WES is still the place where we will keep our KCRSPA memorabilia.
- -We had a great turnout for our "Read Across America" day in our county elementary and middle schools.
- -For our June 5th meeting/luncheon, we will sail on the Chester River Packet. The menu will be the same as it was last year, and the cost will be \$50.00.
- -Officer installation will occur on the packet on June 5th.
- -Our membership includes 99 members!
- -There are (4) KCHS scholarship recipients. They will receive \$1,000.00 on Senior Awards night on May 14th. Sue Crooks and Brenda Shorter will present the awards.
- -Nina needs legislative news from Betty which will complete Nina's information for the KCRSPA webmaster page.
- -Maryland's 1974 teacher of the year, Eloise Johnson, has a booklet dedicated to this honor for her, which we will donate to Sumner Hall.
- -Kent County teacher honorees: (cards of congratulation will be given to each):

Cheryl Fricasse = Teacher of the Year (2025) Madison Kendall=Promising Educator (2025)

Ralph Johnson=Support Employee (2025)

Also, at each Tea Party event in May, the animal shelter has a booth with items for sale to help the with the upkeep of the shelter. Volunteers are needed and hired as young as 16 years of age, and all high school students of age are welcomed to volunteer and will receive Service learning hours from the Kent County Animal Shelter.
